the undersigned sutherity, a Notary Public, duly commissioned and legally qualified in and for the State and Parish aforesaid, personally came and appeared the several parties, all of the full age and majority, whose signatures are hereunto subscribed, who declared, in the presence of the undersigned competent vitnesses, that, availing themselves of the provisions of the Laus of the State of Louisians, and particularly R.S. 12:101 to 12:155, both inclusive, they do hereby organize a non-profit corporation, as defined in R.S. 12:101(8), under and in assertions with this Charter or these Articles of Incorporation:

MITCH I.

The name of this corporation shall be The Abbeville ROZARY CLUB.
APPLIES II.

THE AMENVILLE BOTTOMY CLUB shall be dominibed in Abbeville, Vermilion Parish, Louisians.

APPROLE III.

This corporation shall be a non-profit corporation and its purposes shall be charitable and benevalent.

The objects for which this corporation is formed are as follows:

- To encourage, premote, and extend the objects of Rotery International and to unintern the relations of a number club in Rotery International.
- 2. To operate and carry on the antivities of a civic club on a number club in Rotery International, subject to the

jurisdiction of Rotary Interestional immedia as the provisions of the lase of the State of Louisiana shall possit, and without limiting the generality of the foregoing, to carry on and to continue the work and activities of the present civic club knows as The Abbeville Botary Club, and acquire all its property and to assume its obligations.

- 3. To encourage and foster the ideal of service as a basis of worthy enterprise, and in particular to encourage and foster:
 - a. the development of acquaintence as an opportunity for service;
 - b. high ethical standards in business as professions; the recognition of the worthiness of all useful cocupations; and the dignifying by each number of his occupation as an opportunity to serve society;
 - c. the application of the ideal of service by every member to his personal business and community life;
 - d. the advancement of interpretable good will and peace through a world followship of business and professional men united in the ideal of service.
- watertakings, and projects for absritable, educational, and other benevalent purposes, for the promotion of social velfers in general, especially in consection with youth estivities, and for the purpose of raining and obtaining funds to be used for shartbable, absorbinal, or other benevalent purposes consistent with the general objects and purposes for which the corporation is created.

In order properly to presente the shore stated objects and purposes, the corporation shall have full power and anthority to lease, purchase,

asquire by gift, device or bequest, own, hold, operate, develop, sell, rest, pladge, sortgage, or otherwise asquire, dispose of, ensumer, or deal in or with, ruel or personal property of any nature, and generally the componetion shall have the power and suthority to do any and all things which may be deemed secessary or expedient for the proper and successful prosecution of the objects and purposes for which it is created.

ARTICLE IV.

This corporation shall enjoy corporate existence for a period of ninety-nine (99) years from the date boreof.

ARTICLE V.

The location and post office address of the registered office of this corporation shall be Abbeville, Louisians

ARTICLE VII.

This corporation shall be organised without capital stock and numbership shall be evidenced by cortificates of undership.

Participation in its affairs shall be by membership in this corporation.

The binds of numbership, the basis and qualifications for each kind of numbership, the rights, privileges and responsibilities of each kind of numbership and the rules governing education to and termination of numbership shall be, in so far as permitted by the lass of Louisiana, in accordance with the provisions of the standard also constitution, and any numbership thereto, adopted and approved by Notary International, which provisions shall be contained in the by-lasse of the conjunction adopted as bereinsfor provided.


