



## Couples Membership

### Couples Membership Program & Dues

1. Both members must apply for, be accepted, and maintain ACTIVE membership requirements as defined by Rotary International Policies and Rotary Club of Abbeville Bylaws;
  - a. The Couples Membership (aka Spouse/Partner Membership) is a specific membership program of Abbeville Rotary and is a designation solely for the purpose of setting and billing club dues.
  - b. It does not apply to any other Rotary Club or has any corollary designation within Rotary International or The Rotary Foundation.
  - c. Both members are expected to support financially and actively participate in the club, district, and global projects.
2. Couples Membership dues may be applied for when:
  - a. A spouse or partner are both members of the club;
  - b. Reside at the same home address; and
  - c. Dues for both members are billed and paid for in a single invoice.
3. Dues for the Couples Membership are as follows:
  - a. The first member pays the full dues structure of the Rotary Club of Abbeville,
  - b. The second member only pays the required dues set forth by District 6200, Rotary International, and is encouraged to pay the sustaining member dues to the Rotary Foundation.
4. Both members must each have an individual (non-shared) email account.
5. The Couples Membership does not include or apply to other residents or family members at the same address.
